Safe Deposit Boxes



If you currently have a safe deposit box at another financial institution now might be the time to consider changing it to your credit union. Our rates are very reasonable. The rent is charged annually from the date of opening and can be withdrawn from your savings account. We have four different sizes. The annual rent is as follows:

3" x 5"	\$10.00
3" x 10"	\$20.00
5" x 10"	\$30.00
10" x 10"	\$45.00

All of the boxes are 24 inches deep.

BASEMENT RENTAL



Did you know that your Credit Union has a great room that is available for you to rent?

It is a perfect size for smaller receptions, birthday parties, family reunions.

To rent please contact the Credit Union office at 913-682-2928.

The fee to rent is \$15.00 per hour with a three hour minimum if no alcohol is served
Or \$25.00 per hour with a three hour minimum if there is going to be alcohol served.

There is also a \$100.00 deposit with is returned after the party provided there is no damage done.
